## Skip Payment Form

I request to skip the following loan payment(s) and will pay a \$35 Skip Payment fee:

By participating in One Community Federal Credit Union's Skip Pay program, you request that One Community Federal Credit Union defer your loan payment as indicated. You can only skip one payment at a time and a maximum of twice within a 12-month rolling period. A minimum of 120 days is required between skipped loan payments per loan. Your loan(s) must be current (have no amount past due) to accept this offer. You agree and understand that: 1) Finance charges will continue to accrue at the rate provided in your original loan agreement, during and after this time; 2) deferring your payment will result in your loan having to pay higher total finance charges than if you made your payment as originally scheduled; 3) the payment deferral will extend the term of your loan(s) and you will have to make extra payment(s) after your loan(s) would otherwise be paid off; 4) you will be required to resume your payments the month immediately following the month chosen to skip; 5) a fee of \$35 per loan per skip will be deducted from a savings or checking account. All deferrals are subject to One Community Federal Credit Union approval. Certain restrictions may apply. Excludes all real estate loans. Indirect loans may require additional paperwork.
